<p>The Royal Children's Hospital</p> <p>The Royal Children's Hospital's (RCH) vision is A world where all kids thrive.</p> <p>RCH is located within the Melbourne Biomedical Precinct, with more than 45 world-class biomedical organisations and more than 50,000 of the brightest minds working together to make the Precinct number one in the Asia Pacific region for health, education, research, and training. Within this, RCH is also a cornerstone member of the Melbourne Children's Campus, partnering with Murdoch Children's Research Institute, The University of Melbourne Department of Paediatrics and The Royal Children's Hospital Foundation. Each organisation contributes to a paediatric academic health centre which is greater than the sum of its parts.</p> <p>RCH has cared for the children and young people of Victoria for more than 150 years since it was founded in 1870. A full range of paediatric and adolescent health services are provided plus tertiary and quaternary care for the most critically ill and medically complex patients in Victoria, Tasmania, southern NSW and other states around Australia and overseas. The RCH is the only provider of heart transplant services and CAR T-cell therapy for paediatrics in Australia. RCH is an effective advocate for patients and their families with a particular focus on vulnerable children and increasingly, mental health in young people. The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.</p> <p>We work collaboratively with hospitals to deliver the right care, in the right place, at the right time. <p>ROLE CONTEXT</p> <p>The Royal Children's Hospital has seen an exponential growth in clinical trials across the campus. It is expected that access to clinical trials for the paediatric population will continue to grow requiring a pharmacy service to facilitate research and access to novel therapies.</p>

ROLE PURPOSE
<p>The Clinical Trials pharmacist is required to assist the responsible Grade 3 Pharmacist in the provision of clinical trial pharmacy services.</p> <p>The role requires support for clinical drug trials throughout the RCH and campus partners, with responsibility for the set-up, day to day management and closure of clinical drug trials.</p> <p>Participation in relevant committees and sub-committees is necessary. Review of standard operating procedures in line with RCH and legal requirements is also performed.</p>
