# The Royal Children's Hospital

The hospital also supports many health promotion and prevention programs. The Hospital has more than 6,000 staff, a budget of \$850M, 12 wards and 350 beds. Annually, the RCH has 300,000+ Specialist Clinic appointments, 90,000+ Emergency Department presentations and 20,000 elective surgeries.

## **ROLE CONTEXT**

The Victorian Paediatric Palliative Care Program (VPPCP) is an alliance between The Royal Children's Hospital, Monash Health and Very Special Kids, but managed by and under the auspices of the RCH. The VPPCP team is comprised of medical, nursing, and allied health staff. The Program uses a multi-disciplinary consultation- liaison model of care that provides consultation to health professionals across Victoria in the acute paediatric and community palliative care sectors. Primary responsibility for day-to-day patient care remains with the treating unit and community palliative care team. The VPPCP also manages a Flexible Funding Program which provides funding for services and equipment which families cannot access through other programs. In addition to clinical consultation and liaison, one of the aims of the VPPCP is to build the capacity of the broader health care system to provide the best possible palliative care to children and their families regardless of diagnosis. This is done through education, research and advocacy.

## **ROLE PURPOSE**

The Senior Palliative Care occupational therapist (OT) provides clinical leadership and expertise that optimises quality of life for paediatric palliative care patients and families. It is largely a consultancy role and includes the provision of equipment and expert advice to both health professionals and families about:

- Mobility and independence
- Personal Care
- Pressure care
- Safety (e.g. safe transport in vehicles, transfers)
- Assessment of the home environment and equipment needs of children who are discharged home
- Organisation of the hire or purchase of necessary equipment
- Working closely with rural health care providers to facilitate home care for children.

The VPPCP OT will at times prescribe and source specialist equipment when this is not available through existing services and agencies.

Working in close collaboration with other VPPCP staff, the OT will support children and families through education and recommendations about living with a life-limiting illness and about grief.

# **KEY ACCOUNTABILITIES**

## **Provision of Care:**

- Design, develop and deliver excellent evidence based assessment and intervention for the specialist needs (e.g. mobility, seating, pressure care) of children with life-limiting conditions
- Assume responsibility for efficient and equitable access to VPPCP equipment; Sourcing specialist equipment in circumstances where this cannot be obtained through existing agencies/services/funding
- Initiate and strengthen existing relationships between the VPPCP and community palliative care services; as well as other internal and external service providers.
- Build capability of community palliative care services to provide care to children and their families
- Facilitate timely discharge of palliative care patients whose families wish to care for them at home
- Where needed, visit patients at home as soon as possible after discharge, ideally with the community-based palliative care service
- Provide high level of clinical expertise with independent decision making Act as a specialist clinical resource for patients, carers, nursing, medical, allied health care professionals within and beyond the RCH
- Provide secondary consultation to hospital and community based clinicians in relation to the care of children requiring palliative care



- Participate in interdisciplinary patient care conferences
- Ensure continuity of care is provided by liaising with relevant professionals and departments
- Provide clinical input into the development of individualised care plans for children requiring palliative care
- Demonstrate a family centred, holistic approach to care
- Demonstrate a consultative, collaborative and multidisciplinary approach to care
- Provide leadership in the OT support of patients needing palliative care to health professionals in both the paediatric and palliative care sectors
- Maintain accurate documentation of all patient-related activity, including completion of all system required data and detailed medical record documentation in keeping with organisational, professional, and legal requirements.

## **Collaborative Practice**

- Actively participate and lead relevant networks and forums and develops strategic relationships with key community, disability, paediatric and palliative care service providers
- Demonstrated experience working with initiative, autonomy and leading others in the pursuit of team goals
- A flexible and adaptable approach to functioning in a team environment that enhances the team's performance to ensure ongoing excellence in service delivery and teamwork

# Communications

- Highly developed verbal communication, interpersonal skills and attention to detail with the ability to interact with a variety of stakeholders
- Recognises issues that may lead to conflict, and constructively addresses issues as they arise
- Communicate effectively with patients and families to ensure their understanding and that their needs and views are included in plans and actions.
- Facilitate open and effective communication across all levels of the [Discipline/ Department] and more broadly across the organisation.

## Continuous Improvement and Research

- Develops effective time management skills to balance clinical requirements and to contribute to continuous improvement activities.
- Balances priorities between clinical load and contribution to quality improvement activities.

- Evaluates current practice with respect to the evidence.
- Finds, critically reviews, evaluates and interprets literature and applies to current role/service.

- Work under general direction with autonomy

# **QUALIFICATIONS AND EXPERIENCE**

- Bachelor of Occupational Therapy or equivalent tertiary qualification
- Eligibility for membership with Occupational Therapy Australia
- Registered to practice as an Occupational Therapist with the Australian Health Practitioner Regulation Agency (AHPRA)
- Previous relevant experience specific to paediatric occupational therapy practice
- Experience in caring for children with palliative care needs

## **Desirable:**

- At least 7 years' clinical experience
- Post-graduate qualification relevant to role at Master level (or significant completion towards)

## **KEY SELECTION CRITERIA**

- Comprehensive knowledge and assessment and intervention skills specific to paediatric palliative care
- Highly developed problem solving and clinical reasoning to support complex decision making, care planning and coordination.
- Demonstrated interest or experience in research, quality improvement or program evaluation
- Demonstrated strong clinical leadership and organisation.
- Highly developed interpersonal skills and an ability to communicate with and motivate children, young people and their families and to negotiate with multiple stakeholders in a professional, efficient, and sustainable manner.
- High-level written skills, including clinical documentation, performance reporting and/or business cases.



- Ability to work well under pressure and be flexible to changing priorities
- Demonstrated computer skills, including spreadsheets, database programs, and word processing programs
- Skills and experience as a member of a team including a willingness to contribute to team initiatives, share knowledge and educate others
- Knowledge of the issues confronting children with life-limiting conditions and their families
- Knowledge of the principles of palliative care and key elements of practice
- A capacity to work in both hospital and community settings
- Ability to monitor the management of children with palliative care needs and their families through the treating healthcare and community teams
- Demonstrated capacity to manage stressful situations and conflict
- Commitment to Quality Improvement principles, and evidence of initiation, implementation, and completion of projects aligned to service enhancement.
