# **ROLE PURPOSE**

This is a new role that will assist with quality use of medications predominantly in the Paediatric Intensive Care Unit (PICU) and Neonatal Intensive Care Unit (NICU). Working collaboratively with the pharmacists, the Pharmacy Technician will manage stocks of high-cost medications that they will manufacture in the sterile unit to reduce wastage and improve financial sustainability.



#### **KEY ACCOUNTABILITIES**

- Develop and implement the PICU & NICU position
- Provide comprehensive, professional, and high-quality technical support in the provision of pharmaceutical services.
- Work independently in technical tasks, being able to prioritize own workload and refer to the pharmacists where appropriate and with ward staff about discharge planning.
- Monitor the wards medication room to ensure imprest supplies are relevant and storage conditions are safe.
- Monitor expiry dates and stock rotation to reduce risks of waste
- Check and assess inpatient high-cost medication supplies and run reports on the EMR to determine appropriate manufacturing requirements
- Collect data and report on KPIs in relation to manufacturing, waste, and cost savings
- Manufacture sterile/non-sterile following the requirements of clean room working and aseptic technique when required.
- Work collaboratively with the senior pharmacists to expand services to reduce wastage across the department
- Liaise with the pharmacists, medical and nursing staff regarding high-cost medication requirements
- Adhere to all legislative requirements, hospital guidelines, accreditation, and professional standards.
- Actively participate in pharmacy and hospital education.
- Assist in other areas of the department at times of shortage and during busier periods
- Participate on the weekend and public holiday roster
